

# Maryland Underground Facilities Damage Prevention Authority AUTHORITY MEETING Minutes Wednesday, October 4, 2017

#### Call to Order, Attendance Roll Call & Welcome

The meeting was called to order by Authority Chairman, Tom Hastings at 9:08 a.m. in the Miss Utility Call Center, Conference Room, 7223 Parkway Drive, Suite 200, Hanover, MD 21076.

## **Authority Financial Report:**

The Executive Director provided financial statements as of September 30, 2017. He reported that the Operating Account has a balance of \$158,083.43 and the Education and Outreach Account has a balance of \$25,498.93 There were no legal fees for the month of September. The July revenue from the Miss Utility surcharge was \$17,221.80, which off by ~\$3000.00 over last year's distribution. The cumulative total for 2017 is currently \$129,716.40. The Executive Director also stated that the Final Report is being prepared for the 2016 PHMSA SDP grant. Ms. Stroud was able to make the case for reallocating \$21,701.05 of the unspent 2016 grant funds toward offsetting her salary as the acting part-time investigator. That leaves \$1825.66 in unused funds that will have to be returned to PHMSA.

A motion to accept the financial report was made by Chairman Hastings, and seconded by member Gainer. The motion was approved by acclamation.
