Old Business:

PHMSA State Damage Prevention Grants – The Deputy Directed informed the members that the PHMSA Grant program is still on hold. She contacted Hung Nguyen with the agency's state programs division regarding a possible timeline. He indicated that the grant applications might become available in late spring.

Agenda Item 8

New Business:

Greater Chesapeake Damage Prevention Training Conference – The Authority has been asked if they are willing to be a repeat gold sponsor for \$3,750.00. The conference is at the newly renovated Ashore Resort in Ocean City, October 21st – 24th. Chairman Wilkins made a motion to approve the sponsorship, which was seconded by Secretary Inanloo, the motion carried by acclamation. In addition, there was discussion about using the booth space which comes with the sponsorship. The members agreed that the Authority should use the booth space and the members who are attending are willing to help man the booth. The Chairman also suggested that the Authority send a member to the conference. Most of the members are already attending, but Secretary Inanloo said she was interested in attending. The members agreed that having the Board Secretary attend was a good idea. The Chairman asked the Deputy Director to make the arrangements.

Construction Angels Sponsorship – The Deputy Director presented sponsorship opportunities with Construction Angels. The members were given materials regarding State Level Sponsorships and suggested that the Authority consider becoming "Bronze "level Sponsors which has a yearly cost of \$2,500. She noted that the Authority would be recognized on the CA's website and would also be recognized on monthly fundraiser emails and news letters . Member Jennings made a motion to approve the CA state bronze level sponsorship for \$2,500. Member Dill seconded the motion which carried by acclamation.

Commencing of Hearings – the Executive Director ,as a follow on to the members plans to begin holding hearings has asked the Authority's legal counsel to give a short instructional regarding proper conduct during hearings. Mr. Finemore gave a very informative overview of how hearings work and the roles and rules the members should follow. The Executive Director reminded the Board that Hearing days could be "all-day" meetings and so members should plan accordingly.
